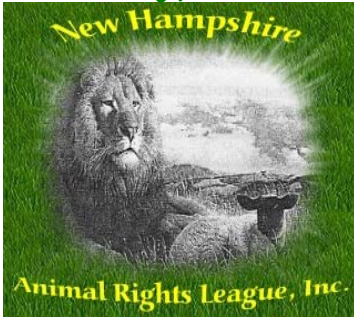

National Primate Liberation Week (October 11 –19, 2008)

...is an annual program of Stop Animal Exploitation Now (SAEN) to bring attention to the plight of primates used in research. In October NHARL members Kat Ranalletti, Sherry Bezanson and Linda Dionne held a protest at Dartmouth College to protest their use of rhesus macaque monkeys in cruel and unnecessary experiments. They were joined by some activists from Vermont. The Valley News printed a front page story of the protest and there was also an article in the Concord Monitor. The Great Ape Protection Act (GAPA) is legislation which will end invasive research on chimpanzees and release the chimps remaining in federal laboratories to sanctuary. GAPA is currently in committee in the U.S. House of Representatives and will be reintroduced early in the 2009 session when Congress returns.

Greyhounds Win Landslide Victory!

We are proud to announce that Massachusetts voters have overwhelmingly passed Question 3, the Greyhound Protect Act, by a margin of 56% to 44%!!! This is the first time in history that dog tracks have been closed down by citizens vote.

November 4th, the greyhounds won in 12 of 14 counties. From Boston to the Berkshires and Nantucket to North Adams, voters in nearly 290 towns said "yes" to ending 75 years of cruelty.

This is a fantastic win for dogs in Massachusetts and it marks the demise of an industry that exploits dogs for entertainment and profit.

Moving forward, GREY2K USA will work to place any and all available greyhounds from Wonderland and Raynham Parks. Stay tuned to learn how you can support this effort as the tracks begin winding down their operations.

As you know, dog racing still exists in 10 other states and we are committed to ending dog racing nationwide. We are grateful for your support of our work.

Proposition 2

Voters in California approved this ballot initiative to halt the inhumane confinement of animals on factory farms.

Wayne Pacelle, President and CEO of The Humane Society of the United States, said, "California voters have taken a stand for decency and compassion and said that the systemic mistreatment of animals on factory farms cannot continue. All animals deserve humane treatment, including animals raised for food."

Proposition 2 ends the practice of confining certain animals raised for food in crates and cages so small the animals can barely move. Prop 2 requires that factory farms provide enough space for animals to stand up, turn around and extend their limbs. It applies to breeding pigs, egg laying hens and veal calves.

Prop 2 goes into effect in January of 2015, giving factory farms six years to shift to different housing systems.

World Farm Animal Day (WFAD)

...is a day dedicated to exposing, mourning, and memorializing the needless suffering and slaughter of the more than 55 billion cows, pigs, turkeys, chickens and other sentient land animals in the world's factory farms and slaughterhouses. This is another of the annual projects of Farm Animal Rights Movement (FARM). NHARL members Laura Slitt, Tricia Orr and Linda Dionne served free vegan food on October 6 in front of the Statehouse in Concord, NH. Vegetarian starter kits, courtesy of Mercy for Animals, were distributed. FARM posted this event on their website and supplied us with literature as well.

Fur Free Friday (November 28)

Last year we held many protests at Dino International Furs in North Hampton and received strong coverage of our protests by various newspapers. We also ran a radio ad on the local radio station. This year we plan to do Fur Free Friday at Dino's. In addition, we would like to do other protests in December and January around the state depending on where our volunteers would like to go. If you would like to plan a demonstration or tabling event in your community please let us know and we will help in every possible way.

***Legislation in 2009

At the request of NHARL, Representative Carla Skinder of Cornish has graciously agreed to introduce legislation to ban pheasant stocking/hunting in NH. Legislators have until November 26 to file a legislative service request (lsr) and we are certain Ms. Skinder will do this next week.

Regarding the NH Fish and Game Pheasant Stocking Program, every year NH Fish and Game purchases some **13,500** farm-raised, non-native, ring-necked pheasants to be released around the state, essentially creating a canned hunt for pheasant hunters. These basically tame birds are sometimes shot minutes after their release, as they are taking their first flights of freedom. The pheasants that are not shot usually die anyway because they are unable to survive New Hampshire winters. Sadly, next year Fish and Game plans to buy even more pheasants for this "put and take" operation.

We will need your help in order for this legislation to pass. As you already know, Fish and Game will be adamantly opposed. Although there is no good argument to keep this program alive, we know Fish and Game will try to put forth some illogical argument couched in jargon to try to convince legislators otherwise. As soon as we know the lsr has been submitted, we will begin working to build support for it. This is where you come in. We will need you to contact your legislators to ask them to support this legislation. Your help will be vital for this to succeed. Keep in touch with us so that we can give you updates. Just give her your phone number and she will call you as soon as action should begin.

Another important aspect of showing our support is to be present when the bill is heard by the Fish and Game committee. The more people we can get in the room, the better chance it will pass out of committee with an "Ought to Pass" recommendation. At the hearing, there will be sign-up sheets to show support (or to show opposition). We are usually outnumbered by the opposition because hunters come out of the woodwork when a bill such as this one is introduced. We will try our best to give plenty of notice as to the day of the hearing.
